Faculty and Staff Highlights: Expanding our Horizons

Our faculty members continue to be exceptional in their reach beyond the classrooms. While doing genealogical research into his family, Professor of Law **<u>Bill Piatt, J.D.</u>**, a New Mexico native, discovered his family's lineage from enslaved



Native Americans, also known as Genízaros. His and other stories were published in the <u>Washington Post</u>. Piatt previously co-authored the book, *Slavery in the Southwest: Genízaro Identity, Dignity and the Law* and was featured in Gary Medina Cook's new documentary, <u>The Genízaro</u> <u>Experience: Shadows in the Light</u>, which will screen at the <u>Santa Fe Film Festival</u> this month.

Jennifer Stevenson, J.D., Assistant Dean for International Programs and Service Professor of Law, has also expanded the borders of the School of Law through her work in Moldova. Stevenson is one of four U.S. subject matter experts working on a grant



program called Advancing Legal Reasoning and Writing
